MANDATED REPORTER REQUIREMENT: NYS has mandated that all school bus drivers complete the "State Mandated Reporting of Child Abuse in an Educational Setting" training course. The course is online and can be done from home. If you do

not have access to a computer or the internet, please contact Carol Ferryman in Safety & Training, ext. 4192 or email cferryman@suffolkbus.com. The course is two hours, and you will receive pay upon completion. You can start the course, stop as needed and pick up where you left off. Please go to the following website and register for the self-directed online training course: http://nysmandatedreporter.org/trainingcourses.aspx. After completion of the course, you will receive an email with your certificate of completion. Please print out certificate emailed to you and provide it to your Supervisor. If you do not have a printer, you can forward the email to your Supervisor. They can provide you with their email address. Upon

receiving your certificate, you will receive 2 hours of pay for the course time. Please complete the course by 12/31/22. Your Supervisors can provide you with more detailed instructions.

BOUNTY BONUS: Refer a friend or family member for a school bus driver position and receive \$1,000! Yes, we are doubling the bounty to \$1,000! And you

receive the referral bonus 60 days after they are assigned a school bus route, no waiting for 6 months. This is effective through 12/31/22. Applicants can visit www.suffolkbus.com to complete an online application or pick up an application at your yard.

401k OPEN ENROLLMENT: 401k open enrollment is here! All forms can be found on MPS, click on Notifications, click Benefits. The forms are also printed at your yard. Don't delay. Deadline for enrollment is 12/23/22 to take effect 1/1/23. The next opportunity to enroll in the 401k will be December 2023.

YARD SAFETY: Our yards are active with buses, personal vehicles, and employees. Yard speed is always under 10 mph whether traveling in a bus or car. Please use the proper entrance and exit gates and stay in the appropriate travel lanes. Employees are to wear Company jackets with the reflective strips so you can be seen. Remember:

- Keep alert when walking in the yard, be mindful of uneven pavement; do not have your head down.
- Always utilize crosswalks where applicable.
- Refrain from talking and texting on your cell phone in the yards.
- Park in marked spots only. Do not block vehicles or double-park in the yard or outside the gates. Your vehicle blocks the view for other drivers to safely navigate. Use the correct driver assistant pick up areas in your yard.
